Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

Amendments were adopted to ARTICLES I, VI, and VII of the Articles of Incorporation of ABC CHARTER SCHOOLS, INC., and are hereby amended to read:

ARTICLE I. CORPORATE NAME.

The name of the corporation is: **KIDZ KORNER, INC.**

ARTICLE VI. BOARD OF DIRECTORS

The corporation shall have three (3) directors initially. The number of directors may be increased or decreased through by-laws adopted by the shareholders, but shall never be less than one.
