ARTICLE I

NAME AND PRINCIPAL MAILING ADDRESS OF CORPORATION

The name of the corporation is: **SUPREME AIRCRAFT SERVICES, INC.** and its principal street address is 7449 NW 49th Court, Lauderhill, Florida 33319 and its principal mailing address is Post Office Box 26702, Tamarac, FL 33321.

ARTICLE II

PURPOSE OF CORPORATION

This corporation is organized for the following purposes:


