

ARTICLE I—NAME

The name of this corporation is **THE PYRAMID CLEANING CORPORATION**

ARTICLE II—DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the **Department of State**.

ARTICLE III—PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as a **Contractual Cleaning Services Company**.

ARTICLE IV—CAPITAL STOCK

This corporation is authorized to issue **100 shares** of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V—PRE-EMPTIVE RIGHTS




