

 - A. Article IV of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - Name

B. The second paragraph of Article VI shall be amended to read as follows:

C. Article VII shall be amended to read as follows:

ARTICLE VII Initial Board of Directors
