The undersigned subscribers to these Articles of Incorporation, natural persons competent contract, hereby form a corporation under the laws of the State of Florida.

#### **ARTICLE 1. - NAME AND ADDRESS**

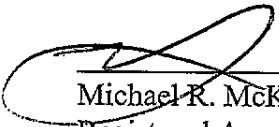
