ARTICLES OF INCORPORATION

OF

STRATEGIC DESIGN CORPORATION

The undersigned natural person, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is: Strategic Design Corporation

ARTICLE II ADDRESS AND REGISTERED AGENT

The street and mailing address of the principal office and the initial registered office of the corporation is 11 Lincoln Avenue South, St. Petersburg, Florida 33711. The name of the corporation's initial registered agent at the registered office is Dianne R. Blyler.

ARTICLE III EXISTENCE

The existence of the corporation will commence upon filing. The corporation shall have perpetual existence.

ARTICLE IV PURPOSE

This corporation is organized for the purpose of entering into any and all lawful businesses permitted under the laws of the United States and of the State of Florida.

ARTICLE V AUTHORIZED SHARES

The corporation is authorized to issue a total of 10,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$0.01 per share.

ARTICLE VII NO PREEMPTIVE RIGHTS

There are no preemptive rights to subscribe to any additional issues of stock of the corporation.

ARTICLE IX INITIAL BOARD OF DIRECTORS

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The name and street address of the initial director is:

ARTICLE X INCORPORATOR

ARTICLE XI AMENDMENTS

The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.
