ARTICLE I - NAME

The name of this corporation is SEMBLER/TREASURE RETAIL, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on August 26, 2002.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK


