ARTICLE I. NAME

The name of this corporation is JAMES DAVIS PAINTING, Inc.

The term of existence of the corporation is perpetual.

ARTICLE III. PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.


