ARTICLE IX. BY-LAWS:

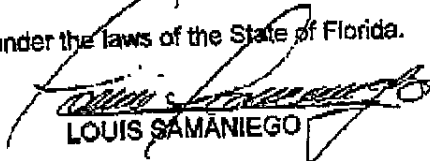
The power to adopt, alter, amend or repeal by-laws shall be vested in the shareholders entitled to vote.

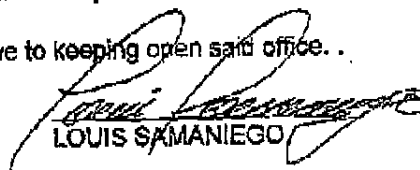
