

The undersigned Incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is THE SEVENTH ANGEL MARKETING, INC. (the "Corporation").
- SECOND:** The street address of the initial principal office and mailing address of the Corporation is 100 S.E. 2nd Street, Suite 3920, Miami, Florida 33131.
- THIRD:** The Corporation is authorized to issue 7,500 shares of common stock, par value \$1.00 per share.
