OF

Metro Florida Management, Inc.

In compliance with the requirements of F.S. Chapter 607 and/or Chapter 621, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I NAME

The name of the corporation ("Corporation") is "**Metro Florida Management, Inc.**"

ARTICLE II BUSINESS AND ACTIVITIES

This corporation may, and is authorized to, engage in any activity or business permitted under the laws of United States and of the State of Florida.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is **ten thousand (10,000)** shares, all of which shall be common stock, at par value **\$0.10** per share. All common stock shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. No shareholder shall transfer, alienate, or in any way dispose of any share of the corporation unless such share shall have been offered to sell to the corporation.

ARTICLE IV TERM OF EXISTENCE

This Corporation shall exist perpetually.
