The undersigned incorporator to these Articles of Incorporation hereby associates to form a corporation (the "Corporation") under Chapter 607 of the Florida Statutes.

1. Name

The name of the Corporation is Slapshots Hockey, Inc. The Corporation's principal office (and mailing address) is located at 14041 Tamiami Trail, Fort Myers, Florida 33912 in Lee County, Florida.
