**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
CONSOLIDATED FLORAL SOLUTIONS INC.,
a Florida corporation**

Pursuant to the Florida Business Corporation Act, Article 1 of the Articles of Incorporation of **Consolidated Floral Solutions Inc.**, a Florida corporation, hereinafter referred to as the "Corporation", is amended to read as follows:

ARTICLE I Name

The name of the Corporation is **Working Employees IV, Inc.**

In accordance with Section 607.0123(1)(b) of the Florida Business Corporation Act, this Amendment shall be effective upon its filing with the Florida Department of State.
