ARTICLES OF INCORPORATION OF ACUTE SOLUTIONS, INC.

The undersigned, acting as incorporator of a Florida Corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I NAME

The name of the Corporation is Acute Solutions, Inc.
