The undersigned, acting as incorporator of a corporation to be formed under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation, to be filed with the Secretary of State of the State of Florida:

#### ARTICLE I

The name of the corporation will be JR INVESTMENTS USA, CORP. The principal place of business of this corporation will be 1596 SW 14 Street, Miami, Florida 33145.

### ARTICLE II

The Corporation will have perpetual existence commencing at the filing of the Articles of Incorporation with the Department of State.

#### ARTICLE III

The general nature of the business to be carried out by the Corporation is as follows:

- To carry on any and all lawful purposes not specifically prohibited or limited by Chapter 607, Florida Statules.
