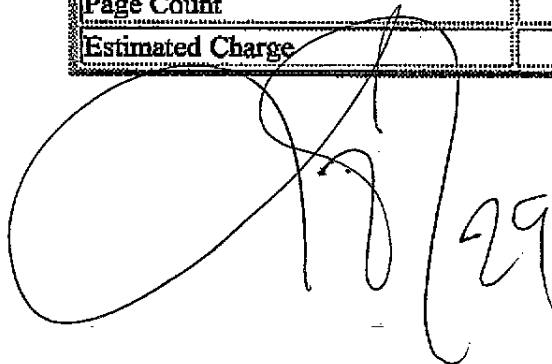

- (i) To elect and appoint officers and agents of the corporation and define their duties and fix their compensation;
- (j) To elect and appoint officers and agents of the corporation and define their duties and fix their compensation;
- (k) To make and alter by laws, not inconsistent with its articles of incorporation or with the laws of the State of Florida;
- (l) To have and exercise all the powers necessary to effect its purpose;

ARTICLE IV

- The aggregate number of shares which this corporation shall have the authority to issue is the total sum of 1000 shares, having an individual per value of \$.01.
- The sum of the par value of all shares stock of the corporation that have been issued shall be stated capital of the corporation at any particular time.
- The holders of the outstanding shares of the stock shall be entitled to receive, when, if and as declared by the Board of Directors, dividends payable either in cash, in property or in shares of the stock of the corporation.
- The corporation's share of stock will not be divided into classes.
- The corporation is not authorized to issue shares of stock in the series.

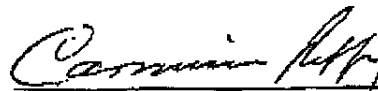
