# ARTICLES OF INCORPORATION OF ISC INTEGRATED SERVICES CORP.

THE UNDERSIGNED, has executed the following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

#### ARTICLE I

The name of this corporation shall be: ISC Integrated Services Corp.

#### ARTICLE II

This corporation shall commence its existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

## ARTICLE III

The general nature if the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do:

1 transact any and all lawful business.

2 Said corporation shall further have powers:

(a) To have perpetual succession by its corporate name;

(b) To sue and be sued, complain, and defend in its corporate name in all actions or proceedings;

(c) To have a corporate seal and to use the same by causing it to be impressed or affixed.

(d) To purchase, take, receive, lease or acquire and otherwise deal in and with real and personal property or any interest therein;

(e) To sell, mortgage, pledge, create a security interest in, lease, transfer and otherwise dispose of all or any part of its property and assets;

(f) To land money to its officers and/or employees.

(g) To make contracts and guarantees and incur liabilities, borrow money, issue notes, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchise and income;

(h) To lend money and take and hold real or personal property as security of the payment of funds so loaned

ISC Integrated Services Corp. Articles of Incorporation (i) To elect and appoint officers and agents of the corporation and define their duties and fix their compensation;

(j) To elect and appoint officers and agents of the corporation and define

their duties and fix their compensation;

(k) To make and alter by laws, not inconsistent with its articles of incorporation or with the laws of the State of Florida;

(1) To have and exercise all the powers necessary to effect its purpose;

## ARTICLE IV

- The aggregate number of shares which this corporation shall have the authority to issue is the total sum of 1000 shares, having an individual per value of \$.01.
- The sum of the par value of all shares stock of the corporation that have been issued shall be stated capital of the corporation at any particular time.
- The holders of the outstanding shares of the stock shall be entitled to receive, when, if and as declared by the Board of Directors, dividends payable either in cash, in property or in shares of the stock of the corporation.
- The corporation's share of stock will not be divided into classes.
- The corporation is not authorized to issue shares of stock in the series.

#### ARTICLE V

The initial principle place of the business for the corporation shall be at 5142 NW 122 Avenue Coral Springs Florida 33076, and this shall be the corporations initial mailing address.

#### ARTICLE VI
