THE NAME OF THE CORPORATION IS: NB CONSTRUCTION OF ORLANDO INC.

ARTICLE TWO

THE PERIOD ,TERM AND DURATION IS PEREPUALITY

ARTICLE THREE

THE BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS BUSINESS AS A FULL SERVICE CONSTRUCTION COMPANY, WHEREIN, WE WILL PROVIDE CONSTRUCTION OF ALL KIND AND OTHER RELATED SERVICES. THE BUSINESS WILL TRANSACT ALL OF ITS BUSINESS UNDER THE NAME OF NB CONSTRUCTION OF ORLANDO INC.
