ARTICLES OF INCORPORATION

OF

AMERI-MIX, INC.

The undersigned natural person, acting hereby as Incorporator for the purposes of forming a corporation for profit under the provisions of the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Ameri-Mix, Inc.

ARTICLE II

The principal office of the corporation shall be located at:

ARTICLE III

The general purposes for which the corporation is organized are:

1. To engage in the business of manufacturing and distributing of dental and other similar products.
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
4. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE IV


