ARTICLES OF INCORPORATION

OF

OCTAVIO CARREÑO, M.D., P.A.

Pursuant to Chapter 621 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a professional services corporation.

ARTICLE I - NAME

The name of the corporation is Octavio Carreño, M.D., P.A. (hereinafter called the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of the Corporation is 1555 Kingsley Avenue, Suite 604, Orange Park, Florida 32073.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of providing professional medical services.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock, par value \$.01 per share.

ARTICLE V - INITIAL REGISTERED AGENT




