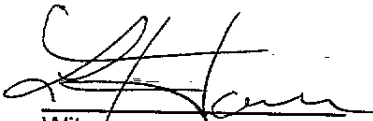
**FOURTH:** The total number of shares of stock which the Corporation shall have authority to issue is One Thousand (1,000) shares, at no par value.

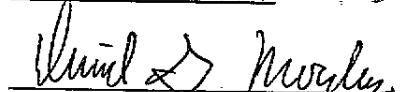
