To Whom It May Concern:

The undersigned holds a power of attorney and is the registered agent on file for the subject taxpayer.

Taxpayer filed a late annual report paying the \$400.00 late fee penalty, the \$150.00 filing fee and the \$8.75 certification fee on a VyStar Credit Union check # 864286782, dated 08/20/03 in the amount of \$558.75. Taxpayer has now received a dissolution notice because, according to the State, there was no federal identification number included on line 4 of the Form UBR. There are two problems with the State's position, (1) the State has Taxpayer's \$558.75 in funds and, (2) Taxpayer never received a "reject letter" with a chance for compliance.

At the same time as the above activity was taking place, The Elite Learning Center, Inc. Doc. No. P02000096680 mailing a check for the same amount of \$558.75 and a UBR without a federal identification number on line 4 (copy attached) was recorded as a proper filing on 09/25/2003.

The State Of Florida must treat both corporation in the same fashion. Both corporation have the same two (2) stockholders. Please make note that the federal ID no. for Little Chuckles Learning Center, Inc. is 47-0896716 and the federal ID no. for The Elite Learning Center, Inc. is 47-0896721.


