# ARTICLES OF INCORPORATION OF TWO TOWNSENDS HOLDING COMPANY, INC.

The undersigned, for the purpose of forming a corporation under The Florida

General Act hereby adopt the following Articles of Incorporation.

#### ARTICLE I

#### <u>Name</u>

The name of the Corporation shall be: Two Townsends Holding Company, Inc.

## ARTICLE II

#### Nature of Business
