The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

<u>ARTICLE I. - NAME</u>

The name of this corporation is VIK FURNITURE, INC.

ARTICLE II. - NATURE OF BUSINESS
