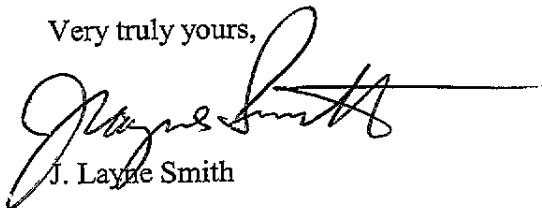

ARTICLE VI. PREEMPTIVE RIGHTS

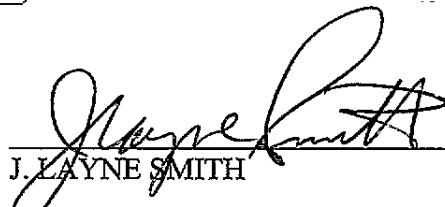
