

ARTICLES OF INCORPORATION
OF
KILGORE CONSTRUCTION AND HOME REPAIR, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

I

The name of the corporation shall be *KILGORE CONSTRUCTION AND HOME REPAIR, INC.*. The principal place of business shall be 11218 Lokanotosa Trail, Orlando, Florida 32817.

II

The duration of this corporation is perpetual unless dissolved according to law.

III

The purposes for which this corporation is organized are:

1. To build, repair, and sell residences to the public.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

IV


