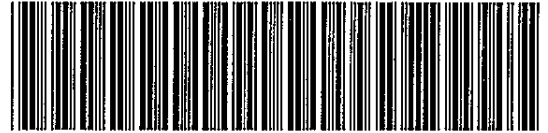

BWA-TECH CORP.

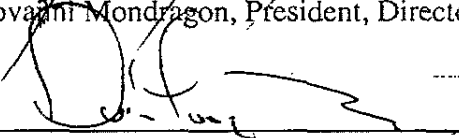

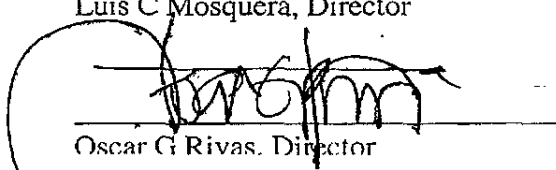
