This Corporation may be a Sub-Chapter S Corporation, as defined by the Internal Revenue Code.

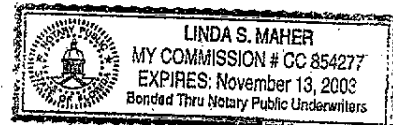
