

# ARTICLES OF INCORPORATION OF MERCURY STUDIOS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

NAME

The name of the Corporation is MERCURY STUDIOS, INC.

#### ARTICLE TWO

DURATION

The term of existence of the Corporation is perpetual.

#### **ARTICLE THREE**

#### **PURPOSE**

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
