ARTICLE IV. CAPITAL STOCK


The aggregate number of shares that the corporation shall have the authority to issue is 7,500 shares of capital stock with a par value of \$1.00 per share.


ARTICLE VIII. INDEMNIFICATION

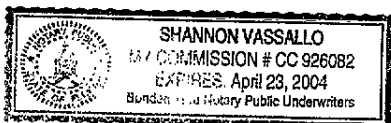
