The undersigned Incorporator to these Articles of Incorporation hereby associates himself together to form a Corporation under the Laws of the State of Florida.

ARTICLE I. NAME

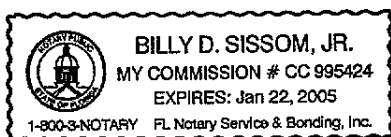
