The undersigned, for the purposes of forming a corporation under Florida General Corporation Act, do hereby adopt the following articles of incorporation:

1. ARTICLE ONE. NAME. The name of the corporation is:
DARBY INK, INC.
2. ARTICLE TWO. PRINCIPAL OFFICE: The principal place of business of this corporation shall be: 1307 Barefoot Bay Circle, Micco, Florida 32976 (772-664-5400).
3. ARTICLE THREE. DURATION. The duration of the corporation is perpetual and its existence shall take effect September 01, 2002.
4. ARTICLE FOUR. PURPOSE. The general purpose for which the corporation is organized are the following:
 - A. To engage in and transact any lawful business for which corporations may be incorporated under Florida General Corporation Act. No other purpose limits this general purpose in any way.
 - B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.
5. ARTICLE FIVE. CAPITAL STOCK. The aggregate number of shares which the corporation is authorized to issue 1000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.
6. ARTICLE SIX. INITIAL REGISTERED OFFICE AND AGENT. The name and address of the initial registered agent and office of this corporation as follows:

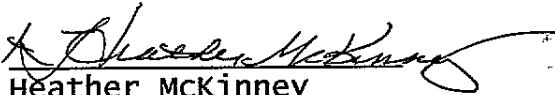

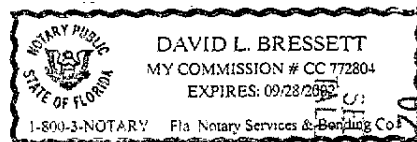
