ARTICLE I - NAME

The name of the corporation is JRM Industries, Inc.

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors.

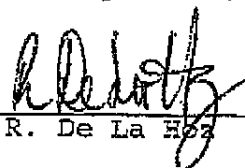
ARTICLE X - INDEMNIFICATION

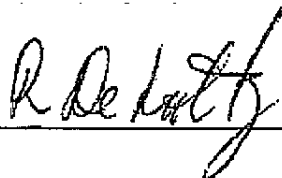
