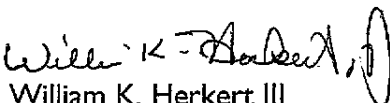

ARTICLE X. BYLAWS

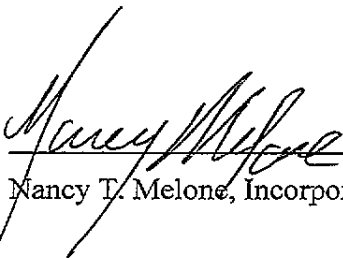

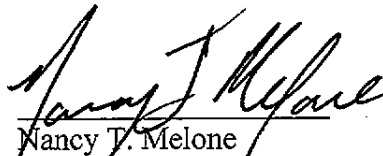
