ARTICLES OF INCORPORATION OF. THE PICTURE FACTORY OF SARASOTA, INC.

Control of the contro The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE ONE

The name of the corporation (the "Corporation") is THE PICTURE FACTORY OF SARASOTA, INC.

ARTICLE TWO

The principal office of the Corporation is 1860 J & C Boulevard, Naples, Florida 34109.

ARTICLE_THREE

The purpose or purposes for which the Corporation is organized are to engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida Business Corporation Act.
