The undersigned, a natural person of the age of eighteen years or over, desiring to form a professional service corporation within the meaning of Florida Statutes, Chapter 621 and the applicable provisions of Florida Statutes, Chapter 607, hereby certifies as follows:

ARTICLE I


ARTICLE VIII


ARTICLE IX
