ARTICLES OF INCORPORATION OF

1. Name. The name of the corporation is: ERIC J. AMUNDSON, D.D.S., P.A.
2. Purpose. The corporation may engage in the business of carrying on a practice of dentistry and rendering professional dental services; provided however, the corporation may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and may own real or personal property necessary for the rendering of such professional services.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1000 shares of common capital stock with no par value.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on September 6, 2002.
