 - 2. If such common directorship, officership or financial interest is disclosed or known to the shareholders entitled to vote

thereon, and such contract or transaction is approved by vote of the shareholders; or

- If the contract or transaction is fair and reasonable as to the corporation at the time it is approved by the Board, a committee or the shareholders.
- B. Common or interested directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or of a committee, which approves such contract or transaction.
