To Whom It May Concern:

The management of Market To Market, Inc. is remiss from a grave oversight in properly remitting our business license renewal requirements. We humbly ask that you wavier the additional penalties as we have made the discovery as a honest mistake, which is systematically corrected to avoid this incident in the future.

As your records will attest, this is the first year Market To Market has been registered in the state of Florida. Our startup circumstances are inline with the unique approach technology sector ventures take. This is a small company. However, it will require a substantial capital outlay up front before revenue generating operations can start. As such, it is necessary to establish the presence of the business on location, having it licensed, as capitalization and budgeting is in process. Capitalization is ongoing from locations outside the newly registered company to build the Florida enterprise. Once the targeted goal is reached, the licensed business will commence services out of South Florida. At this stage, our staff is limited, focused on becoming operational and, consequently, this administrative matter slipped past our schedule of activities. We have programmed into our calendar and ask for your consideration as we have not become truly functional.

We ask that you consider the following in your decision making as justification for abatement of the additional fees:

1. Incentive to encourage business starts. Your act of understanding, will be considered as an agency in touch with business people, more than a set of rules.
2. As a start up in the incubating stage, our activities have not generated any property value, so an assessment is against a negative gain.
