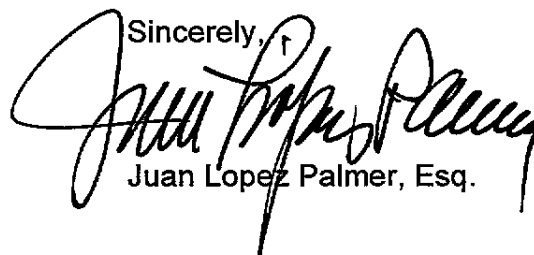

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is GRAPHARMIX MEDIA, INC (the "Corporation").

ARTICLE II

The existence of the Corporation shall be perpetual beginning on the date of acceptance and filing of these Articles with and by the Secretary of State of the State of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 109 W. Yale Street Orlando, FL 32804.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100,000 par value \$.01 per share, all of which shall be Common Shares. 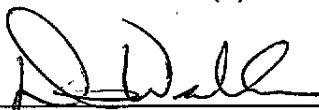
