The undersigned hereby forms a corporation for profit under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be JLM Structures, Inc. The address of the principal office of this corporation shall be 322 East Central Boulevard, Suite 703, Orlando, Florida 32801, and the mailing address of the corporation shall be the same.

**ARTICLE II. NATURE OF BUSINESS**


