This correspondence is with regard to the above-referenced corporation. By way of background, The House Painter, Inc., was duly formed on or about September 5, 2002, by Mr. Larry J. McIntyre. The House Painter failed to file the required Uniform Business Report ("UBR") forms, and requisite filing fees, for the years of 2003, 2004, and 2005. Mr. McIntyre has no record of receipt of the UBR statement from your offices in 2003. The omission of the filing was the result of the culmination of numerous events, including, but not limited to, the death of the accountant for the business and the initiation of subsequent divorce proceedings between Mr. McIntyre and his wife, which proceedings are still pending. Further, as confirmed by an associate with your offices, Tina, the Uniform Business Report forms mailed by your offices were returned by the post office as undelivered.

Based upon the foregoing, this office has been advised, by Tina, and confirmed by Andy, with your offices, that the six hundred dollar (\$600.00) reinstatement penalty is to be waived by your department. On or about November 16, 2005, this Firm, on behalf of Mr. McIntyre, filed an application for reinstatement with your offices and enclosed payment of the past due fees of four hundred fifty dollars (\$450.00) and included eight dollars and seventy-five cents (\$8.75) for a certified copy. A copy of this check is enclosed for your records. This application was returned directly to Mr. McIntyre due to the fact that, during the time of the administrative dissolution, a third party registered a new business with a name that the Division of Corporations deemed to be too similar, thus

preventing The House Painter, Inc., from being reinstated under the same name. However, the payment for reinstatement of the corporation, in the amount of four hundred fifty-eight dollars and seventy-five cents (\$458.75) was processed by the Division and is currently being held on account pending re-filing of the application for reinstatement.

Therefore, please find enclosed the completed Corporation Reinstatement Form and payment from the House Painter, Inc., in the amount of on hundred fifty dollars (\$150.00), that, in conjunction with the four hundred fifty-eight dollars and seventy-five cents (\$458.75) presently being held by the Division, represents the required fees of one hundred fifty dollars (\$150.00) per year for the Uniform Business Report forms that would have otherwise been filed for the years 2003, 2004, 2005 and for 2006. Further, this includes the fee of eight dollars and seventy-five cents (\$8.75) for a Certificate of Status.

Finally, included with the reinstatement application are the Articles of Amendment to the Articles of Incorporation of The House Painter, Inc., changing the name of the corporation. Included with this correspondence are the filing fees, in the amount of thirty-five dollars (\$35.00), and fees for a certificate of status in the amount of eight dollars and seventy-five cents (\$8.75), for a total of forty-three dollars and seventy-five cents (\$43.75), for the name change amendment. Please accept these fees for filing and forward this document to the appropriate department for filing.
