ARTICLE I - NAME

The name of this corporation is: AMC OF NORTH FLORIDA, INC.

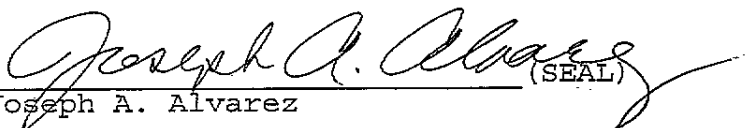
ARTICLE X - INDEMNIFICATION

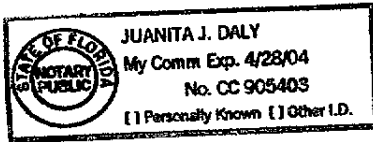
