OF

The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the Statutes of the State of Florida, do hereby subscribe to these Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is:

KID'S HOME DEPOT, INC

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- a) As a Day care center and teaching kids and alike.
- b) Generally, to make and performs contracts of any kind and description, and for the purpose of attaining any of the objects of the Corporation, to the instruction, care and custodian of manors of all ages, to own, hold, personal property of every kind, nature and description wheresoever located, both tangible and intangible and including choses in action, either as owner, broker or factot.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT
