ARTICLES OF INCORPORATION OF: EXCELLENCE TILE & MARBLE, CORP.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby Torm a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

IV.1 This Corporation is authorized to issue 1,000 shares of \$1.00 per value common stock that shall be designated to "Common Shares".



ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. The corporation shall indemnify any office or director, to the full extent permitted by law.


ARTICLE XI DISSOLUTION
