CORPORATE NAME*

TERM OF EXISTENCE*

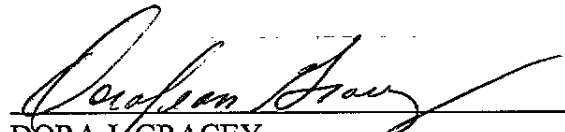
This Corporation shall have perpetual existence commencing upon filing of these articles.

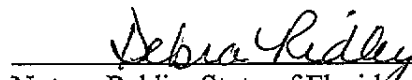
