ARTICLES OF INCORPORATION

OF

SYMBOL INC.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I -- NAME OF CORPORATION

The name of this corporation is **SYMBOL INC.** and its principal place of business shall be located at 980 W. Brevard Street, Tallahassee, Florida 32304-7709.

ARTICLE II -- TERM OF EXISTENCE
