

**ARTICLE I**

**Name**

The name of the corporation is TeeMark Inc. (hereinafter called the "Corporation").

**ARTICLE II**



This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by any law in existence either now or hereafter.


