

**ARTICLES OF INCORPORATION
OF

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the "Florida Business Corporation Act" of the laws of the State of Florida.

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is TWIN BROTHERS WHOLESALE FLOORING, INC., with its principal office located at 1053 SE Holbrook Court, Port St. Lucie, Florida. 34983

ARTICLE II

Nature of Business and Powers


