In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is **G. HOLLAND INDUSTRIES, INC.**

ARTICLE II

The existence of the corporation shall begin on July 20, 2002.

ARTICLE III

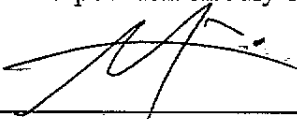
